REQUIRED FOR VALID ENTRY

1. The Owner/Skipper hereby agrees: to adhere to and abide by all of the provisions of the National Yacht Club, the C&C Owners Regatta & Rendezvous Committee, Sailing Instructions, the Racing Rules of Sailing and general conditions. That the boat is well found and in seaworthy condition and that the Owner and crew enter these races of their own desire, governed by the rules of good sportsmanship. It is therefore agreed that neither the Owner/Skipper nor members of the crew shall in any way whatsoever hold the C&C Owners Regatta & Rendezvous, National Yacht Club, the officers, directors, committee chairpersons & employees of the National Yacht Club and/or the C&C Owners Regatta & Rendezvous, the Race Committee or the Protest Committee, or any of them in whole or in part, liable for any damage, accident or loss, including personal injury or loss of life, occurring, suffered or happening to the boat, the Owner/Skipper, or any member of the crew, while on the water or on shore. The Owner/Skipper also agrees to obtain a similar release in favour of the releases from each and every crew member, and in default thereof, to indemnify any of the releases described above and hold them harmless in the event of any claims, demands or actions brought against them by any crew member on the Owner/Skipper's boat.

2. The Owner/Skipper acknowledges that it is the Owner/Skipper's responsibility to ensure that the boat carries all required safety equipment, in good order and that the crew are familiar with its location and means of operation. The responsibility of wearing a life jacket rests upon the Owner/Skipper and their crew.

3. The Owner/Skipper certifies that a valid marine insurance policy covering hull and machinery, and liability is in full force and effect and that a copy of the policy will be on board the boat at all times when racing.
